Sterling Park South Townhouse HOA Newsletter Spring 2015

Get ready for the **Spring Beautification Week!** May 4-9 we will have our annual "best yard" contest, a dumpster placement, and a community "clean-up day" (Saturday May 9th at 10am). This community wide effort will not only improve the aesthetic appeal of our neighborhood, but should also help improve property values in the spring real estate market.

At the April 6th HOA meeting, the Board voted to limit annual inspections of individual properties to only the "big" items. We requested that TWC not be *too* picky this year. We hope this new approach to annual inspections is well received by owners and residents.

We also discussed the final stages of expenditures from the special assessment enacted four years ago. As you know, all parking lots have been completely re-done. It is now time to complete the 5-year project with replacement of a couple retaining walls and new community sign(s). We will also develop a plan for on-going maintenance of the parking lots to maximize their life expectancies and save us money on infrastructure maintenance in the future.

We've had complaints about vehicles parked in our community that do not belong, and we've incurred expenses removing abandoned cars. In addition, we continue to have the same old problems with a few delinquent property owners who rarely (or never) pay HOA dues. After just spending nearly \$300,000 to repair and resurface our parking lots, it is not fair that people who do not live in the community or don't pay for maintenance, are permitted the same usage as the rest of us. We owe it to ourselves to keep track of who uses our parking lots. Legal counsel has recommended that we consider a parking resolution to better manage the parking lots in the future. So I am inviting all membership to come to the next Board meeting (Monday, June 22nd) to discuss this issue in open forum.

Trash Totes

Trash is collected by American Disposal every Tuesday and Friday. Please be reminded that your trash totes must remain in your fenced in backyard out of public view. The only time that your trash tote should be outside of your fenced-in backyard is the evening before trash collection days. All other times your trash tote must remain within your fenced backyard. Trash tends to gather around containers that are left in the common areas, compounding the trash littering the property. Homeowners are encouraged to report properties in violation to TWC Management.

Meet at the big dumpster which will be placed behind N. Concord Court just for this event. We will have trash bags to assist with the community wide clean-up. Annual property inspections are coming up soon! Please keep in mind that we must adhere to our by-laws, setting forth standards for the exterior appearance of properties within the community. Some of the violations we have noticed over the recent months are fallen lamp posts, spray painting on fences, trash and debris in and around the rear fences, and "indoor" furniture "outside" of houses.
