So please do your part and clean up your yards, keep an eye out for the trash dumpers, and report them to the police.

Trash Totes

Trash is collected by American Disposal every Tuesday and Friday. Please be reminded that your trash totes must remain in your fenced in backyard out of public view. The only time that your trash tote should be outside of your fenced-in backyard is the evening before trash collection days. All other times your trash tote must remain within your fenced backyard. Trash tends to gather around containers that are left in the common areas, compounding the trash littering the property. Homeowners are encouraged to report properties in violation to TWC Management.

A big dumpster will be placed behind N. Concord Court just for this event. We will be delivering trash bags to assist with the community wide clean-up. Architectural Changes

Please remember that any and all changes to the exterior of your home must be approved by the architectural review committee. This includes decks, fences, doors, sheds, etc. Other items that need approval include color changes and landscaping modifications. The ARC request form is available on the website, www.SterlingParkSouth.com. Keep in mind that you will need to provide as much information as possible with your application. This includes drawings, color samples, pictures, specifications, plat of your property, etc. If you have questions feel free to contact TWC Management.



Smoke alarms are one of the best and easiest safety features you can have to alert you and your family if there is a fire in your home. The Loudoun County Fire and Rescue offers free smoke alarm assessments to Loudoun County residents. During the visit, fire-rescue personnel ensure the home is adequately protected by working smoke alarms. They also provide valuable information on other fire safety topics. To request an assessment visit www.loudoun.gov/smokealarms and complete the online form or contact your local fire-rescue station.

Spring Has Sprung! Start your Spring cleaning with these safety tips:

- Test your smoke alarms, and replace any alarms that are 10 years old or older.
- Test your carbon monoxide alarms, and replace any alarms that are 7 years old or older.
- Check your dryer vents and clean the hosing.
- Clean clutter inside and outside your home.
- Check the cords on your appliances. If any are cracked or frayed, repair or replace them
- Practice your home fire escape plan.
